### ORDER

- 2. AND WHEREAS, the ERC in its 272<sup>nd</sup> meeting held on 30<sup>th</sup> 31<sup>st</sup> May & 1<sup>st</sup> June, 2019 considered the matter and observed as under:
  - (i) The institution has fulfilled all criteria as per NCTE Regulations, 2014 in compliance to revised recognition order.

In view of the above, the Committee decided as under: A letter be issued to the institution in this regard.

- 3. AND WHEREAS, the letter was not issued to the institution and the matter was re-considered by ERC in its  $274^{th}$  meeting held on  $15^{th} 16^{th}$  July, 2019 under the agenda item No. 272.14.57 before confirmation of proceedings of  $272^{nd}$  ERC meeting.
- 4. AND WHEREAS, the ERC in its  $274^{th}$  meeting held on  $15^{th} 16^{th}$  July, 2019 rectified with following observation:-
  - (i) In the submitted approved list of faculty by affiliating body received from Govt. of West Bengal, faculty comprises 09 regular (1 Principal + 8 lecturers) only. The institution is entitled for running one unit (50 intake) of B.Ed. course as per NCTE Regulations, 2014.

The intake for **B.Ed. course** be **reduced from 100 to 50** from the academic session **2020-2021** with intimation to the institution and all concerned.
